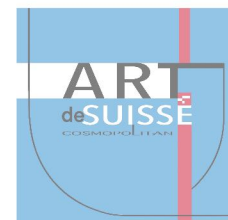

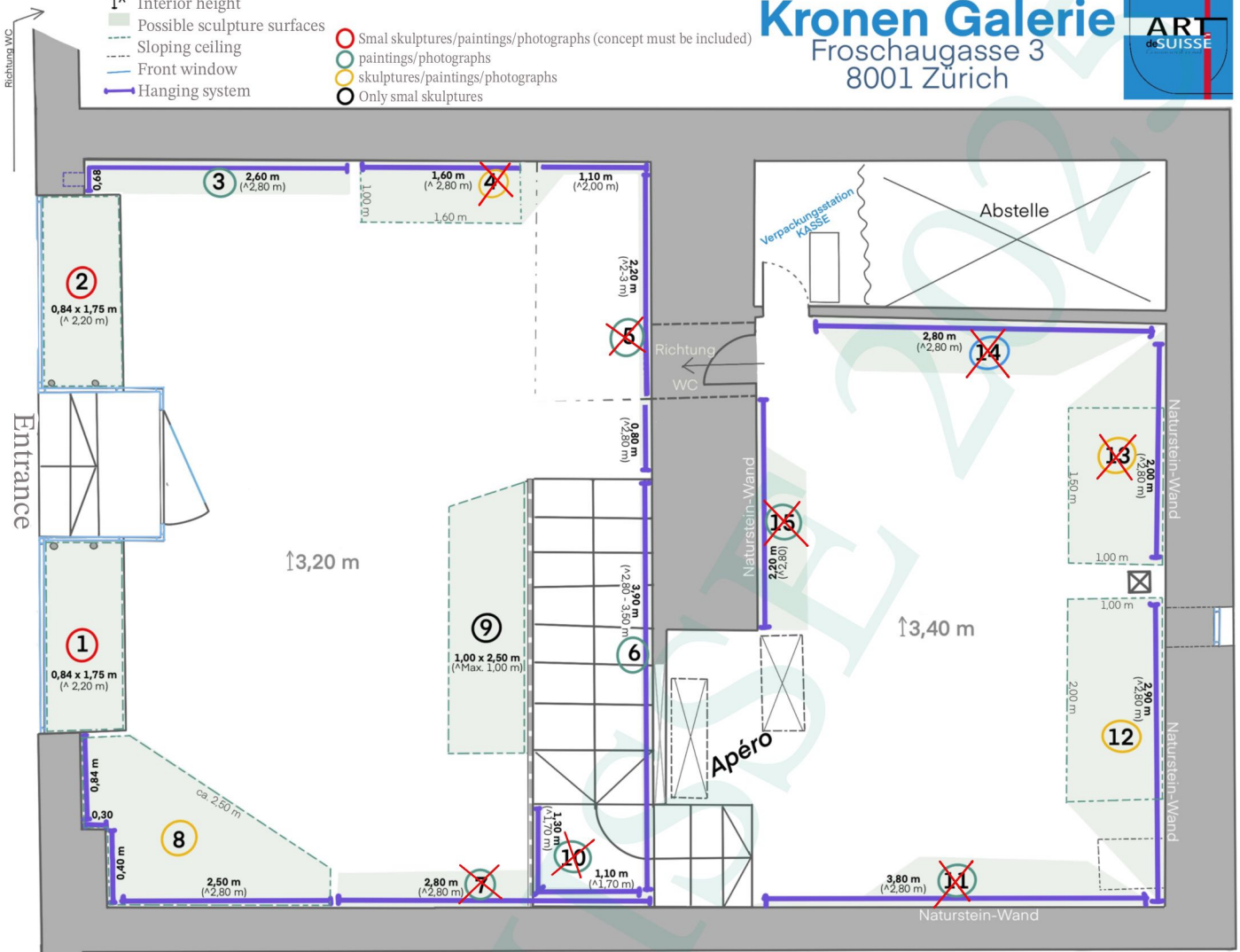

## SALE ARTWORKS

The sales commission is 10% of the sales price (incl. credit card commission).

The sale can also be processed independently by the participant. An own credit card system is recommended (SlumUp)

Upon receipt of your completed and signed registration form, the invoice will be issued and sent. Once ARTdeSUISSE has received payment, the reservation is confirmed. You will then receive the exhibition regulations and other documents.

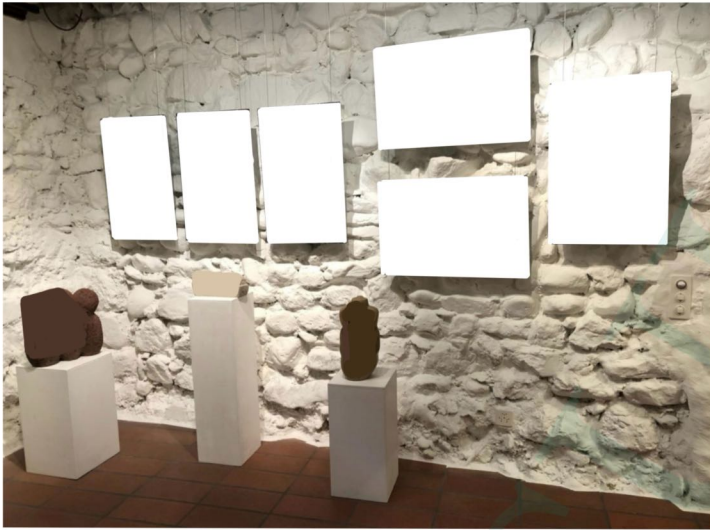
Payments may only be made directly by the contractual partner. Payments from third party accounts will not be accepted.

Price labelling obligation: the exhibitor is obliged to indicate the sales prices of the works of art in Swiss francs (CHF). The prices must be displayed in an easily accessible and legible form (you will receive a price tag template).

Pictures may not be presented standing on the floor.

The organiser or its service provider accepts no responsibility for incorrect or inadequate data, images, photos and texts.

The organiser cannot give any guarantees for the business success of individual exhibitors or for a certain number of visitors.

The exhibitor is liable for any damage caused by him/her or a person authorised by him/her to buildings, stands, installations, persons or goods of third parties.

The organiser is not liable for claims for damages on the part of the exhibitor. The organiser is not liable for loss of sales profits for any reason whatsoever. The organiser shall not be liable for loss, damage, destruction, disappearance or theft of exhibits, materials, stand materials or personal items exhibited or not exhibited.
